**E LAS-PAL01:** (SMS) Institutions must nominate their students by an on-line nomination. Instructions will be sent to our partners every year. Students, should attend the Faculty in which we have an agreement, having the option of taking courses of other faculties, only if it does not exceed the 40% of the total of courses in the learning agreement.

**(STA):** The applications must be sent to the coordinator of International Relations of the Faculty in which we have an agreement.

**(STT):** Every May our Institution organizes an event to receive staff.
